

State of New Hampshire 2014 Open Enrollment



November 22, 2013 - December 6, 2013

All changes made during this open enrollment period are effective January 1, 2014.

You must complete an open enrollment form if you want to:

- Contribute to a medical or dependent child care flexible spending account (FSA) in 2014
- Elect, change or waive benefits for 2014
- Add or remove eligible dependents*
(*Proof of eligibility is required if you want to add a new dependent.)

No action is required if you are keeping the same benefits and do NOT want an FSA in 2014

Important Note:

*All forms and proof of eligibility to add a new dependent to coverage **MUST** be received by your agency benefit representative on or before December 6, 2013.*

ANNUAL ENROLLMENT REQUIRED FOR Flexible Spending Accounts (FSA)

Your FSA benefits require an annual enrollment. If you want an FSA in 2014, you must enroll during open enrollment.
