## Appeal of Dale Purington

January 15, 1987

On November 12, 1986, the New Hampshire Personnel Appeals Board issued a decision in the probationary termination appeal of Dale C. Purington. The Board ordered that the appellant be reinstated in his former or similar position within the Department of Administrative Services to recommence his probationary period. Subsequent to that order, the Board was advised by letter dated December 3, 1986 from Gerald Boucher, Mr. Purington's former supervisor, that he had notified Mr. Purington that he would be reinstated to his former position effective December 8, 1986. Such notification was sent to Mr. Purington by certified mail with a copy sent to his lawyer. A response was requested by December 4, 1986.

In his letter, Mr. Boucher advises the Board that no response was received to his letter to Mr. Purington. Mr. Boucher has now filed a request with the Board asking whether additional action is necessary on his part to comply with the Board's order. In reviewing the record, the Board notes that no requests for reconsideration were filed within the appeal period. It is therefore the Board's finding that the employer has complied with the Board's order and no further action is required by the Board at this time.
