Re: Resignation In Lieu Of Termination


Dear Acting Commissioner:

I respectfully request that I be allowed to resign from my position as a Groundsman with the New Hampshire Technical Institute. I have reviewed the proposed termination letter dated February 3, 1998, and have considered the evidence used in support of the termination letter. My decision to resign in lieu of termination does not constitute an admission of any of the allegations against me, and I vehemently deny all of the allegations. I understand that your acceptance of my resignation precludes any other settlement of this dispute and any further appeal.

I am submitting this letter of resignation with the understanding that anyone who asks the Department will be told that I have resigned, and will not be told that this resignation is in lieu of termination. My decision to submit this resignation and waive my appeal rights is contingent upon my separation from employment being described as a resignation. If any future comments are made by the Department regarding termination, I reserve the right to withdraw my resignation and resume my appeal.
