I am requesting the approval to exercise the last extension provision allowed for statewide contracts 8002220 & 8002221. The current contracts were implemented on October 1, 2017 for two (2) years with additional extensions up to four (4), as a result of RFB #2026-18.

I have verified through System for Award Management that there are no records of debarment or exclusions listed. I am working closely with NH Department of Corrections, NH Hospital, Veteran's Home and Glenciff Home as well as various vendors to provide specification and product listing feedback. DAS has also surveyed EasiBuy and have identified this as a consideration for Reverse Auction bid process. This process may have a significant cost savings, but will also identify and source new potential vendors, specifications and feedback on vendor and specification outline. The estimated annual spend on these contracts is \$1,525,720.00.

The vendor has agreed to extend under the same terms, conditions and pricing structure. I recommend the extension of the contracted based on the information provided above and believe that to do so would be in the best interest of the State.






I am requesting the approval to exercise up to a five (5) month extension provision allowed for statewide contracts listed above. The current contracts were implemented in 2017 for two (2) years with additional extensions, as a result of RFB # 2026-18 and 1938-17.

The intent of the extension is to align the majority of the contracts together and do a single bid with multiple awards and one expiration date. Currently we have Baked Goods, Non Perishables, Frozen and Fish all separate bids with various term dates. We may award multiple vendors, but to align the term dates will make the most sense and try to leverage better pricing at the same time.

I have verified through System for Award Management that there are no records of debarment or exclusions listed. I have also surveyed (Dept of Corrections, NH Hospital, DNCR and smaller DHHS divisions) and they have indicated that the vendor is performing well. The estimated spend on the contracts is \$1,205,720.00 for Dry Goods and \$320,000 on the Frozen Goods for the term of the contracts.

The vendors have agreed to extend under the same terms, conditions and pricing structure. I recommend the extension of the contracted based on the information provided above and believe that to do so would be in the best interest of the State.




