





This Second Amendment (hereinafter referred to as the "Amendment"), dated this 12 day of October, 2018, is by and between the State of New Hampshire, Department of Administrative Services (hereinafter referred to as "the State") and Concord Compassionate Cleaners LLC (hereinafter referred to as "the Contractor") for Janitorial Services.

WHEREAS, pursuant to an agreement effective October 15, 2018 set to expire June 30, 2021, (hereinafter referred to as "the Agreement"), the Contractor agreed to perform certain Janitorial services for the State in consideration of payment by the State of certain sums as specified therein; and

WHEREAS, pursuant to Section 18 of the Agreement, the Agreement may be amended by an instrument in writing executed by both parties;

NOW, THEREFORE, for and in consideration of the mutual promises set forth in this Amendment and the underlying Agreement, the parties do mutually agree as follows:
