RESTOCKING FEE: Return authorizations and credits will be provided without penalty for all items listed in the current product list that are unused, unopened and undamaged for a period of six (6) months form date of purchase.

CONTRACT PRICE, RATES and PAYMENT TERMS:

INVOICING:

Invoicing shall be done on the basis of each delivery. Contractor shall render separate invoices for each sale or delivery to the State department or agency to which sale is made. Invoices shall clearly indicate the quantity delivered, date of delivery, contract number, delivery location and contract price including all State/Federal taxes and fees. The charges levied against applicable items to support the used oil disposal fee will be shown as a separate line item on the invoice and added to the total due. If applicable, invoices for products delivered in returnable drums must show a cross reference to the invoice number under which the drum deposits charge will be billed.
