PRICE ADJUSTMENTS:

Contractor may request price increases during the term of the contract, however price increase for any product shall not be in excess of prices being charged to the general trade or the Contractor's best/preferred customer at the time of delivery. Written notice of an impending price increase, including substantiation for it, must be submitted in writing to Bureau of Purchase & Property, 25 Capitol Street, Rm. 102, Concord, NH 03301, no less than thirty(30) days prior to the effective date of said price increase. The State reserves the right to reject any price increases it deems unreasonable.
