November 7, 2016 – November 23, 2016

All changes made during this Open Enrollment period are effective January 1, 2017

For the upcoming 2017 calendar year, you must complete an appropriate Open Enrollment form if you want to:

- ❖ Contribute to a medical and/or dependent child care flexible spending account (FSA) in 2017
- ❖ Elect, change or waive your health or dental benefits for 2017, including adding or removing eligible dependents without a qualifying life event
- ❖ Elect, change or drop supplemental life insurance for yourself or dependents

NO action is required if you are keeping the same benefits and do NOT want an FSA in 2017.

New Employee Voluntary Life Insurance Plan Options

Good News! We are announcing an exciting change to the Voluntary Life Insurance plan options offered through Anthem Life, to be effective 1/1/17.

Essentially, the current life plans available now will be offered to you as separate or "stand alone" Employee, Spouse and Children life plans. This change provides you with the flexibility to select the combination of life insurance options that work best for you and your family, at the same rates!
