

REQUEST FOR BID

The New Hampshire Department of Safety is now accepting bids for the publication of the NH Criminal Codes and the NH Motor Vehicle and Boating Laws. All vendors must submit RSA Chapter 263 (Drivers' Licenses) as a sample of your proposed product and the bid by 12:00 noon on August 15, 2016. Bids and samples will be accepted by mail, Fed Ex, UPS or in person by the date and time specified. Late bids will not be honored. The contract will be awarded for one year, with an option to renew for two additional 1-year terms. The following criteria are required for the two books proposed:

- List of RSA Chapters affected by latest legislative session

The bid should include the price for books only as well as books with CD's included. The Department of Safety must receive the book order by December 15, 2016 for distribution.
