PROJECT NAME: Suncook River Stabilization Project – Epsom, NH

PROJECT DESCRIPTION:

In 2006, a large storm and ensuing flood resulted in significant channel change on the Suncook River and Leighton Brook in Epsom, NH. The Suncook River changed course south of Route 4, resulting in channel instability up and downstream from this point. The channel upstream to the U.S. Route 4 Bridge has been eroding vertically and laterally.

The stabilization of the Suncook River will include bank stabilization of approximately 600 feet of bank adjacent to an agricultural field approximately 2,700 feet downstream of the U.S Route 4 Bridge. The work will also include stabilization the channel banks on both sides of the river for approximately 900 feet downstream of the U.S Route 4 Bridge and constructing a grade-controlling stone riffle in the channel approximately 900 feet downstream of the bridge.

This prequalification document is for the Suncook River Stabilization Project. Stabilization of the Suncook River will include the following elements:

- Grading of channel banks
- Sourcing and hauling large quantities of rock
- Installation of rock
- Installation of geotechnical fabric under rock
- Installation of sheet pile across the floodplain
- Installation of fabric encapsulated soil lifts
- Installation of surface erosion control fabric
- Installation of sediment and erosion control measures
- Control of water in a flowing river channel
- Installation of native seed, shrubs, and trees

NOTES:

- 1) Interested Contractor shall submit a statement of qualifications that is applicable to the above named project in accordance with the requirements below:
 - a) Contractor, Project Manager and Field Superintendent shall have experience constructing at least five (5) projects of similar type of river work within the last ten (10) years.
 - b) Project Manager and Field Superintendent shall have a minimum of ten (10) years construction experience working within, and around, rivers and natural resource areas.
- 2) The State reserves the right to reject incomplete applications.
- 3) The State will review each statement of qualifications based upon the criteria in Items 1 through 9 below. Contractors will only be accepted if it is determined that prequalification is in the best interest of the State of New Hampshire. The State may reject contractors based on past project reference feedback.
