QUESTION #1

We received numerous questions regarding the specific brand of shirt and the associated specifications.

ANSWER #1

Please see revised specifications below.

QUESTION #2

It is also mentioned in the document that 1 printed sample needs to be sent to NH Lottery, Maura McCann, 14 and another 2 samples to Lyndsey Whitney and another 3 samples to Dan Ostroth. Are those need to be sent by the bid closing date, or it is after receiving the award.

ANSWER #2

No samples should be sent at bid time. After tabulating the bid we will ask the low bidder to submit a sample shirt. If the shirt is acceptable a PO will be issued. Prior to production printing, a printed sample must go to Maura McCann for approval to proceed with production. Post production products will go to Lyndsey Whitney and Dan Ostroth as stated in the bid.

QUESTION #3

In doing some advanced research, I find the Aqua color comes in many shades and will be 100% cotton. The light grey is more apt to be 90% cotton, 10% polyester. Is it better to match the Aqua color to your downloaded picture with the sample silk screen? If that's the case, the color is more Teal.

ANSWER #3

Specifically the color of the shirt should match that of the shirt on the downloaded picture.

Stock: 6.1 oz. fabric, 90% heavyweight ringspun cotton and 10% polyester – soft washed garment dyed fabric- Yazbek brand
Design 1: Light gray
Design 2: Aqua
Design 3: light gray – long sleeve

CHANGE TO READ:

Stock: All shirts must be 5.8 oz. to 6.1 oz. fabric

Designs 1 and 3 must be either 100% heavyweight ringspun cotton or 90% cotton, 10% polyester heavyweight material
Material must be soft washed garment dyed fabric
Shirts must be equivalent to Yazbek Brand shirts meeting this specification

Design 2 must be 100% heavyweight ringspun cotton, soft washed garment dyed fabric equivalent to Yazbek Brand shirts meeting this specification

Bidder must provide documentation that their offering meets these requirements

Design 3: Light gray – long sleeve
