No more than one (1) proposal per respondent should be submitted.

All RFP submissions must be received at the Bureau of Purchase and Property **no later than 2:00 PM on November 10, 2011.** Submissions received after the date and time specified will be marked as late and will not be eligible for consideration in the evaluation process.

All offers shall remain valid from the proposal submission deadline of November 2, 2011 until the contract effective date. A vendor’s disclosure or distribution of proposals other than to the Department of Administrative Services, Bureau of Purchase and Property, shall be grounds for disqualification. No more than one (1) proposal per respondent should be submitted.
