





**FIRST AMENDMENT TO THE CONTRACT  
BETWEEN NAUGHTON & SON RECYCLING SERVICES INC.  
AND  
THE STATE OF NEW HAMPSHIRE, DEPARTMENT OF ADMINISTRATIVE SERVICES,  
FOR SOLID WASTE & DISPOSAL SERVICES  
CONTRACT # 8001758**

This First Amendment (hereinafter referred to as the "Amendment"), dated this 5<sup>th</sup> day of ~~JUNE~~<sup>JULY</sup>, 2016, is by and between the State of New Hampshire, Department of Administrative Services (hereinafter referred to as "the State") and Naughton & Son Recycling Services Inc. (hereinafter referred to as "the Contractor") for Solid Waste and Disposal Services.

WHEREAS, pursuant to an agreement effective July 1, 2015 set to expire October 31, 2018, (hereinafter referred to as "the Agreement"), the Contractor agreed to perform certain Solid Waste and Disposal Services for the State in consideration of payment by the State of certain sums as specified therein; and

WHEREAS, pursuant to Section 18 of the Agreement, the Agreement may be amended by an instrument in writing executed by both parties;

NOW, THEREFORE, for and in consideration of the mutual promises set forth in this Amendment and the underlying Agreement, the parties do mutually agree as follows:

1. Amend Exhibit A, Scope of Services bullet point 13 to read:

The State reserves the right to change the size of the container, or the frequency of pick-up, for any of the locations throughout the term of the contract without making additional written amendments to the contract as long as any additions do not cause the payment and pricing to exceed the price limitation of the contract. Additionally, The Contractor may also suggest "right sizing" varying in sizes/ or frequency to each location for cost effectiveness. All requests for change shall be made by the contracting officer.

2. All other provisions of the Agreement, approved by the Commissioner, Department of Administrative Services on June 17, 2015, shall remain in full force and effect.
