



**FIRST AMENDMENT TO THE CONTRACT  
BETWEEN PINARD WASTE SYSTEMS INC.  
AND  
THE STATE OF NEW HAMPSHIRE, DEPARTMENT OF ADMINISTRATIVE SERVICES,  
FOR SOLID WASTE & DISPOSAL SERVICES  
CONTRACT # 8001760**

This First Amendment (hereinafter referred to as the "Amendment"), dated this 6<sup>TH</sup> day of June, 2016, is by and between the State of New Hampshire, Department of Administrative Services (hereinafter referred to as "the State") and Pinard Waste Systems Inc. (hereinafter referred to as "the Contractor") for Solid Waste Disposal Services.

WHEREAS, pursuant to an agreement effective July 1, 2015 set to expire October 31, 2018, (hereinafter referred to as "the Agreement"), the Contractor agreed to perform certain Solid Waste and Disposal Services for the State in consideration of payment by the State of certain sums as specified therein; and

WHEREAS, pursuant to Section 18 of the Agreement, the Agreement may be amended by an instrument in writing executed by both parties;

NOW, THEREFORE, for and in consideration of the mutual promises set forth in this Amendment and the underlying Agreement, the parties do mutually agree as follows:

1. Delete the following paragraph in Exhibit A, Scope of Services bullet point 10 in its entirety:  
Additional containers can be added or upgraded to the contract in the future as agreeable between the parties.
2. Amend Exhibit A, Scope of Services bullet point 13 to read:  
The State reserves the right to change the size of the container, or the frequency of pick-up, for any of the locations throughout the term of the contract without making additional written amendments to the contract as long as any additions do not cause the payment and pricing to exceed the price limitation of the contract.
3. All other provisions of the Agreement, approved by the Commissioner, Department of Administrative Services on June 17, 2015, shall remain in full force and effect.
