**CONTRACT TERM:**

The term of the contract shall be from the **June 24, 2015** through **June 30, 2018**, a period of approximately THREE (3) years. The contract may be extended for an additional two (2) years thereafter under the same terms, conditions and pricing structure upon the mutual agreement between the Contractor and the Bureau of Purchase and Property with the approval of the Commissioner of the Department of Administrative Services. The maximum term of the contract (including all extensions) cannot exceed five (5) years.

**TERMINATION:**

The State of New Hampshire shall have the right to terminate the purchase contract at any time by giving the successful Vendor a thirty (30) day written notice.

**CONTRACT PRICES:**

The DISCOUNTS and PRICES shall remain firm for ONE YEAR. PRICE INCREASES WILL BE ACCEPTED AFTER ONE YEAR AS THE SUBMITTED PRICE SCHEDULE CHANGES, BUT THE DISCOUNTS WILL REMAIN FIRM. Discounts and prices shall include delivery and all other charges.

**ELIGIBLE PARTICIPANTS:**

Political sub-divisions (counties, cities, towns, school districts, special district or precinct, or any other governmental organization), or any nonprofit agency under the provisions of section 501c of the federal internal revenue code, are eligible to participate under this contract whenever said sub-division or nonprofit agency so desires. These entities are autonomous and may participate at their sole discretion. In doing so, they are entitled to the prices established under the contract. However, they are solely responsible for their association with the successful Vendor. The State of New Hampshire assumes no liability between the successful Vendor and any of these entities.

**ABILITY TO PROVIDE:**

Contractor must be capable of providing each State of New Hampshire agency, institution, political sub-divisions and authorized non-profit organizations with their entire requirements of **STORAGE BATTERIES** without any delay or substitution.

**ORDERING PROCEDURE:**

State agencies and institutions shall place their orders in person, by telephone, facsimile, E-mail or mail as needed.

Political sub-divisions and authorized non-profit organizations shall utilize their own individually established ordering procedures.

**DELIVERY TIME:**

The Contractor shall be required to accomplish delivery of any item ordered under the contract within TWO (2) working days from the receipt of the order.

**WARRANTY REQUIREMENTS:**

Manufacturer's warranty shall apply

Warranty shall start when battery is put in service.

Agency may require rotation of stock after 6 months of being on their self.

VENDOR WILL BE RESPONSIBLE FOR THE WARRANTY REQUIREMENTS.

**INVOICING:**

Invoicing shall be done on the basis of each order completed. Invoices shall clearly indicate the quantity, description, packaging, date of delivery, contract number and contract price.

**CORE EVACUATION:**

Contractor shall remove all cores on a weekly basis or on a schedule agreed upon the using agency and the Contractor

Responsibility for cores will end for the State of New Hampshire when picked up by the Contractor.

All cores will be on an exchange basis with no core value.

**CATALOGS/PRICE LISTS:**

As prices increase, the Contractor will supply an updated PRICE LIST AND CATALOG to the Bureau of Purchase and Property.

The Contractor will supply a SALES/PRICE LIST AND CATALOG to requesting agencies.
